He is the Senior Responsible Officer for project Manawa – Measuring what matters for Māori, and is responsible for our Māori capability program Te Aho Kura.

Previously, Atawhai managed the development of Te Kupenga 2013, the first indigenous wellbeing survey undertaken by a national statistics organisation.

An experienced policy advisor, Atawhai has worked as Private Secretary to two Ministers and has held senior advisor roles at the Ministry of Education, Te Taura Whiri i te Reo Māori, Te Puni Kōkiri, the State Services Commission, and more recently, the NZ Treasury.
